Construction bids of first fiber to the home contract came in (northwest corner of the Heights). Two bids came in that were over budget but contingency plan was written into bid, which made one bid within budget. Wanda has been sending letters to property owners to see if they have buried capability or overhead. Has put FAQs on Port website. She is getting new questions and info every day. Wanda is grateful to the BAT for list of providers and their services and to the library for the digital navigator program. She is planning a meeting for interested parties and property owners and would like library to be there as well as internet providers, specifically First Step and Inland Cellular.
